


Afterschool State Funding Overview:



Decreasing Invenstments In Afterschool & Summer

- Decrease in CCDF (29%) and 21st CCLC (2%) Funds
- Reallocation of State Funds
- Sunsetting ARPA Funds
- 41% Decrease in Funding

Despite increasing demand, availability is slipping.



Kid-Related Legislation during 2025 Session

- Slashing future funding (aka income tax cut)
 - HB106 = Kids lose out on another \$216 mil/yr
 - Since 2018 = more than \$1 BILLION
- School vouchers
 - May just be a funding request
- Attacks on immigrant kids
 - Multiple anti-immigrant bills announced
 - Rolling back health care access (State CHIP)
- Removing safety guardrails that protect kids
 - Childcare (and homeschool)

Kid-Related Legislation during 2025 Session

- Improving, investing in childcare
 - Childcare subsidies for childcare workers
 - Return to responsible oversight
 - "Public-private partnership" using state buildings
 - Business tax credit
- Expanding state preschool grant program
- Child Tax Credit expansion
- Preserving Native families, cultural ties
- More funding for proactive Youth Services programs




Federal Policy Outlook: The New Administration

- Shift schools to prioritize job readiness, workforce pathways, Project Based Learning, and apprenticeships/internships
- Local and state control: block grants to states to determine use of funds; school choice and vouchers
- Eliminate or de-emphasize the Department of Education
- Cut federal spending, increase efficiency (DOGE)
- Child care neutral
- STEM: supportive for jobs
- Extend Tax cuts
- However important to note many of these were priorities for previous Trump Administration

Reconciliation

What: Mandatory spending (No changes to 21st CCLC) – Tax Credits– Could determine how much money is available in govt budget overall for appropriations

When: Potentially very soon (Before FY 25 Budget is Finalized)

Who: Budget Committee, Authorization Committees, Everyone

FY 25 Appropriations

What: Discretionary funding levels for all programs (21st CCLC, Title I, CTE, AmeriCorps, CCDBG) – SAVE 21st CCLC

When: Current Continuing Resolution (extension) expires March 14

Who: Appropriations Committees and Approps LHHS Subcommittees (Everyone)

FY 26 Appropriations

What: Discretionary funding levels for all programs (21st CCLC, Title I, CTE, AmeriCorps, CCDBG) – SAVE 21st CCLC

When: After FY 25 Appropriations are finalized, suggested amounts by summer, final due by Sept 30, 2025

Who: Appropriations Committees and Approps LHHS Subcommittees (Everyone)

Federal Opportunities to Advance Afterschool



Bipartisan support for 21st Century Community Learning Centers - no proposed cuts to 21st CCLC in House nor Senate FY 2025 spending bills – advocacy needed to ensure that continues to be the case



Momentum for better access to federal Child Care funds for school-age and afterschool programs in both Republican and Democrat Child Care Development Fund legislation; possible opportunities as part of tax debate



Bipartisan, bicameral legislation around afterschool funding and national service that could get traction in 119th Congress

Afterschool Has Broad Appeal

Demand is higher than ever and support is strong across political affiliations


83% say afterschool and summer programs are an **absolute necessity** for their community







8 in 10 want their elected federal, state and local leaders to **provide more funding** for afterschool programs

Building relationships with representatives is key to protecting and growing funds for afterschool and summer programs



Engaging with Lawmakers

To lawmakers, we are the experts

They count on us to share our experiences and knowledge.

Unfortunately, lawmakers stay busy

If they are unable to meet with you, their staff are eager to listen.

Lawmakers love hearing from their constituents

 Start with the folks representing your district. If you know lawmakers in other districts, ask them to connect you to your representatives.

Reach out in a variety of ways

 Write, call, text, email, send a carrier pigeon. Visit the capitol or your lawmakers or visit their local offices.

Year-Round Advocacy

- Even if bills aren't up for your cause, make introductions and educate
- Follow up after the legislative session
- Program and site visits
- Op-Eds and Letters to the Editor
- Social Media Campaigns
- Encourage members of congress to join the Afterschool Caucus
- Reach out to municipal leaders
- Participate in national advocacy events
- Join a Regional Network
- Ask the UAN team to join you!

Summer Advocacy Tips:

- Visit the state capitol and have kids in your program write letters to municipal, state, and federal leaders about why they love your summer program.
- The Interim takes place between legislative sessions, making it the perfect time to invite policymakers to tour your program. Don't be shy about asking them to join you for an activity!

Fall Advocacy Tips:

- Policy makers are preparing to write bills for the upcoming legislative session, so it's the perfect time of year to encourage parents to let them know how important your program is to families
- Invite your local, state, and federal leaders to your Lights On Afterschool Event in October!
- Interim Committees meet outside of the legislative session to focus on specific issues.
 Attend a meeting to learn about upcoming priorities. You can testify to share your thoughts on upcoming legislation.

Empowering and Motivating Afterschool Champions

- Parents and kids are our greatest champions!
 - How does afterschool impact their ability to work and spend time with their kids?
 - What are impacts for families when kids are on waiting lists or programs aren't available in their area?
 - What are stories about how afterschool has directly impacted them?
- How do programs impact schools and the community?
 - Engage with schools to talk about increased academic support, behavioral changes, etc.
 - Encourage other community members to speak up for afterschool such as businesses, city council members, etc.
- Give them specific resources and give them a specific task.
 - "I'm glad you love our program, please call your legislator and tell them."
 - Please tag your legislator in your social media post about our program.
