Run a Safe Program

There are many questions to consider when choosing whether or not to open your program this fall. The CDC recommendations include 3 basic questions:

- Will reopening be consistent with applicable state and local orders?
- Are you ready to protect children and employees at higher risk for severe illness?
- Are you able to screen children and employees upon arrival for symptoms and
- history of exposure?
- After these questions have been answered with a yes, then you are prepared to start figuring out the next steps. You will want to be prepared with guidelines and procedures for handwashing, sanitizing and group structures.





Due to the changing risk level in the state and across the nation, we recommend that you closely follow updates from the state and CDC, however, here are a few key practices that should be in place regardless of risk level.

- Practices to consider would include doing a "Wellness Check" of staff and participants upon arrival, limiting outside visitors, frequent handwashing, and social distancing.
- When planning your groups, arranging for small group sizes is encouraged. These groups (including the assigned staff) should be kept separate so that participants only have contact with the others in their group while at your program.
- Work closely with local schools to help continue school-day separation (ex- a division by grade or classrooms) in your program space.
